Please allow this correspondence to serve as notice of a rate adjustment to the current firefighting and emergency services agreement by and between Rural Metro Corporation and Hidden Valley Fire District. New annual charges will be in effect as of 1 July 2023. The annual rate is consistent with the provisions defined in the current agreement. The adjustment shall be as follows:

*On 1 July 2023, the Contract Fee shall be \$365,904.00 which shall be paid in semi-annual installments of \$182,952.00.*

All other recitals and articles will continue as stipulated in the most current Fire Protection Services Agreement. The enclosed endorsement should be executed and return to our office on/or before 30 June 2023. A second signed endorsement is provided for your records.

'ADDENDUM' (2023)

The consideration to be paid Rural/Metro Corporation by Hidden Valley Fire District, for the twelve-month period beginning 1 July 2023 and continuing through 30 June 2024 shall be THREE-HUNDRED SIXTY-FIVE THOUSAND, NINE-HUNDRED FOUR AND 00/100 DOLLARS (\$365,904.00) payable in two semi-annual installments of ONE-HUNDRED EIGHTY-TWO THOUSAND, NINE-HUNDRED FIFTY-TWO AND 00/100 DOLLARS (\$182,952.00) to be due on 15 November 2023 and 15 May 2024 of the contract period.
